
UN WARNS OF GROWING MONEY LAUNDERING, SHADOW BANKING RISK FROM MEKONG CASINOS

On 29 October, the VoA reported that transnational criminal gangs are using SE Asia's booming and increasingly digital gambling industry as a shadow banking system to covertly move and launder ever more dirty money, UN officials have told VOA. UNODC believes the region's casinos and online gambling sites now handle tens, if not hundreds, of billions of dollars in returns a year from illegal gambling, drug trafficking, cyberscams and other organised crime.

US: IMPORTS PRODUCED BY FORCED LABOUR

On 25 October, a briefing from the US Congressional Research Service was concerned with section 307 of the Tariff Act of 1930 which prohibits importing any product that was mined, produced, or manufactured wholly or in part by forced labour, including forced or indentured child labour. US Customs and Border Protection (CBP) enforces the prohibition.

CLUSTER MUNITIONS: BACKGROUND AND ISSUES FOR US CONGRESS

On 25 October, a briefing from the US Congressional Research Service was concerned with cluster munitions, which are air-dropped or ground-launched weapons that release a number of smaller submunitions intended to kill enemy personnel or destroy vehicles. The Convention on Cluster Munitions (CCM), which bans the use of cluster munitions, entered into force in 2010, but the US is not a party to the Convention.

IRELAND: CRIMINAL ASSETS BUUREAU ANNUAL REPORT - SUSPECTED CRIMINALS WITH TAX BILLS FOR €8.9 MILLION

On 29 October, the Irish Mirror reported on the CAB annual report saying that it shows that it returned €6.3 million in cash to the Exchequer last year that it had seized from suspected criminals; with suspected criminals given with tax bills for €8.9 million last year – including demands of almost €3 million against suspected drugs dealers.

US HALTS EXPORT OF MOST CIVILIAN FIREARMS AND AMMUNITION FOR 90 DAYS

On 29 October, the Guardian reported that the US has stopped issuing export licences for most civilian firearms and ammunition for 90 days for all non-governmental users, citing national security and foreign policy interests. The pause also includes shotguns and optical sights. An urgent review will assess the "risk of firearms being diverted to entities or activities that promote regional instability, violate human rights, or fuel criminal activities".
