## TRI-SEAL COMPLIANCE NOTE: OBLIGATIONS OF FOREIGN-BASED PERSONS TO COMPLY WITH US SANCTIONS AND EXPORT CONTROL LAWS

On 6 March, the DoJ, Department of Commerce, and OFAC, have issued this Note which says that companies outside of the US should be aware of how their activities may implicate US sanctions and export control laws. This Note highlights the applicability of US sanctions and export control laws to persons and entities located abroad, as well as the enforcement mechanisms that are available for the US Government to hold non-US persons accountable for violations of such laws, including criminal prosecution. It further provides an overview of compliance considerations for non-US companies and compliance measures to help mitigate their risk.

### AVIATION: GUIDANCE ON EU 'NO RE-EXPORT TO RUSSIA' CLAUSES

### **UK SIGNS UP TO 2019 HAGUE CONVENTION**

On 5 March, Jones Day reported that on 12 January, the UK signed up to the 2019 Hague Convention on the Recognition and Enforcement of Foreign Judgments in Civil or Commercial Matters. This will facilitate the mutual recognition and enforcement of judgments across the world (but, in particular, in Europe). ## US: COURT DISMISSES CHILD LABOUR CASE AGAINST TECHNOLOGY COMPANIES AND REFUSED TO HOLD THEM ACCOUNTABLE FOR THEIR ALLEGED SUPPORT OF THE USE OF CHILDREN IN COBALT MINING IN THE DEMOCRATIC REPUBLIC OF CONGO (DRC)

On 7 March, Jurist reported that former cobalt miners and their representatives had filed a lawsuit against 5 big technology companies - Alphabet, Apple, Dell Technologies, Tesla and Microsoft under the Trafficking Victims Protection Reauthorization Act 2008 (TVPRA). They claimed that the companies, by purchasing cobalt through the global supply chain, were involved in a "venture" with their suppliers that engaged in forced labour of children to obtain the metal.

# UK: SFO SECURES CONVICTION OF FORMER MoD OFFICIAL FOR TAKING £70,000 IN SECRET KICKBACKS

On 6 March, a news release from SFO advised that it had secured the conviction of former Ministry of Defence (MoD) official Jeffrey Cook for misconduct in public office, by taking secret payments in

## FORMER CRYPTO DIRECTOR BANNED FROM LEAVING AUSTRALIA AFTER BLOCKCHAIN GLOBAL COLLAPSED OWING \$58 MILLION

On 28 February, the Guardian reported that a former director of the Australian crypto company Blockchain Global, which collapsed owing creditors \$58 million, has been banned from leaving the country. The Australian Securities and Investments Commission secured the interim travel ban in the federal court on 20 February after successfully arguing the director, Liang "Allan" Guo, a Chinese citizen, posed a flight risk.

## OVER 260 TONNES OF RUSSIAN TIMBER ENTERED BELGIUM IN BREACH OF EU SANCTIONS

On 2 March, the Brussels Times reported that at least 261 tonnes of timber were imported into Belgium from Russia despite sanctions following the invasion of Ukraine in February 2022. It explained that Russian timber imports were banned in the fifth round of EU sanctions, ratified by Member States in April 2022. After a period of grace allowing importers to honour contracts, a strict embargo has been in force since July 2022.
