### CRYPTO MIXER SAMOURAI WALLET'S CO-FOUNDERS ARRESTED FOR MONEY LAUNDERING

On 24 April, the Wall Street Journal reported that Keonne Rodriguez, Samourai's chief executive, and William Lonergan Hill, its chief technology officer, were arrested and charged. Prosecutors allege Samourai executed more than \$2 billion in unlawful transactions and helped launder more than \$100 million of illicit funds from dark web markets.

### ISLE OF MAN: POLICE INVESTIGATION INTO 2 GAMBLING COMPANIES

IOM Today and others reported on 25 April that the gambling regulator has suspended the licences of 2 companies amid an ongoing criminal investigation - King Gaming Ltd and Dalmine Ltd. The former received planning permission last year for a project described as the 'largest single private investment in the Isle of Man' and which was said would create around 300 jobs. It is reported that King Gaming Ltd is the B2C arm of the company, while Dalmine Ltd was set up to provide B2B gaming and is a sub-licensee of Asia-owned King Gaming. According to reports on a local news forum (which may, or may not, be reliable), the suspension of the license was preceded by an operation that allegedly involved armed police being deployed and a number of individuals being detained.

On 25 April, the Island's FSA issued a news release advising that it had issued a direction to a TCSP firm, Soteria Solutions Limited, directing that it is to take the action of suspending all designated business undertaken by the firm. It is said that the firm, involved in virtual or crypto-asset business, has shared directors and officers with the King Gaming group of companies.

### A MORE COMPREHENSIVE PLAN TO PUSH BACK AGAINST CHINA'S FISHING PRACTICES

In total, the criminal group is believed to be responsible for the theft of at least 170 books, causing financial damages amounting to around €2,500,000 and an immeasurable loss to society.



### US: PROPOSED BILL WOULD BLOCK LARGE RANSOMWARE PAYMENTS BY FINANCIAL INSTITUTIONS

On 11 April, the ABA Banking Journal reported that a proposed House Bill would require financial institutions to notify the US Treasury before making a ransomware payment, as well as prohibit payments of more than \$100,000 without prior approval of law enforcement. It says that financial institutions making a ransomware payment of more than \$100,000 must first acquire a ransomware payment authorisation from law enforcement, or the President could waive the requirement if the payment is determined to be in the national interest.

# OFAC TARGETS NETWORKS FACILITATING ILLICIT TRADE AND UAV TRANSFERS ON BEHALF OF IRANIAN MILITARY

On 25 April, OFAC advised that it was sanctioning over one dozen entities, individuals, and vessels that have played a central role in facilitating and financing the clandestine sale of Iranian unmanned aerial vehicles (UAV) for Iran's Ministry of Defense and Armed Forces Logistics (MODAFL), which itself is involved in supporting Iran's Islamic Revolutionary Guard Corps (IRGC) and Russia's war in Ukraine.




