#### NEW COUNTRIES COMMIT TO PLACING EXPORT CONTROLS AROUND SPYWARE TECHNOLOGY

On 4 April, an article from Baker McKenzie reported that the US recently made public that a number of countries have joined a pledge to implement export controls on spyware technology. This is part of a broader initiative to establish trade barriers for cyber-related items that could potentially be used in human rights abuses. The article offered insights from Poland, Germany, South Korea and Japan on these developments.

#### US TO CRACK DOWN ON TRADE 'LOOPHOLE' USED FOR CHINESE "LOW COST" SHIPMENTS

On 5 April, the Wall Street Journal reported that small packages will get more scrutiny as part of a broader trade enforcement strategy targeting a method, favoured by e-commerce giants such as Temu and Shein, that has allowed cheap clothes from China to flow into the US with no duties and little scrutiny. Parcels valued at less than \$800 sent directly from abroad aren't subject to duties and receive little scrutiny from US Customs under the same exemption enjoyed by travellers returning home with souvenirs. The actions announced will include "expanded targeting," laboratory testing and focused enforcement operations.

#### PANAMA PAPERS TRIAL BEGINS IN PANAMA

On 8 April, Yahoo Finance and others reported that, 8 years after the scandal broke, 27 people will be tried in the "Panama Papers" case, which revealed how personalities from all over the world had hidden money through the defunct Panamanian law firm Mossack Fonseca. Among those on trial are the founders of this firm, Jürgen Mossack and Ramón Fonseca Mora, as well as other lawyers and former employees of the defunct firm, who are accused of money laundering.

# REPORT: ILLEGAL CLIMATE-WRECKING SUPER-POLLUTANT REFRIGERANT GASES ARE STILL BEING SMUGGLED INTO EUROPE

On 8 April, a report from the Environmental Investigation Agency has found that significant levels of trafficking persist despite the worsening climate emergency. The evidence suggests that black market traders and traffickers are becoming more sophisticated and adapting their tactics to evade detection. HFC are currently being phased down under the EU F-gas Regulation, but organised criminals attracted by high profits are taking advantage of weak law enforcement to meet the demand. The investigation uncovered evidence of traders primarily sourcing HFC from Turkiye and China to import illegally into the EU.

#### UK: SHOULD THE LAW CHANGE TO MAKE IT EASIER FOR ORGANISATIONS TO APOLOGISE?

On 8 April, the MoJ announced a consultation on whether the law could be updated to make it easier for organisations to offer sincere apologies to those who have been wronged. It explains that the Compensation Act, which became law in 2006, made it easier for public institutions, private companies and their employees to apologise, without admitting liability in civil proceedings. Yet almost 20 years on, there is little evidence this has encouraged businesses to use apologies more as form of reparation.

#### **UK: BORDER FORCE BOLSTER SECURITY MEASURES IN GENERAL AVIATION SPACE**

On 8 April, the Home Office announced new fines of up to £10,000 for international general aviation flights that do not submit advance passenger information online up to 2 hours before departure. From 6 April, pilots, owners and operators of general aviation flights will need to provide advance passenger information online from 48 hours to no later than 2 hours before their departure, otherwise they will be liable for a civil penalty of up to £10,000.

Martinelli, having sought asylum in the Nicaraguan Embassy after being convicted of corruption-related offences and barred from standing, is backing the candidacy of José Raúl Mulino, who was his running mate before he was banned from the race and had served as public security minister during Martinelli's administration (2009-14). Before he was banned, Martinelli held a comfortable lead in the polls, and now Mulino regularly polls 13-25 percentage points ahead of his closest rivals.
