# UK: IS RETRIEVAL DUTY FOR THE RECOVERY OF LOST FUNDS AN EXTENSION OF THE QUINCECARE DUTY?

HFW has published a briefing on the first English judgment on the *Quincecare* duty owed by banks to customers and non-customers since the seminal Supreme Court judgment in *Philipp v. Barclays Bank plc.* While the claim in the case failed, because it was out of time, the court considered what might have happened if it had not been time barred.
